

**AMENDMENT TO THE  
AGREEMENT BETWEEN FIU AND HOTEL**

This Amendment to the Agreement (the "**Amendment**") is entered into on this 22 day of JANUARY, 2016 (the "**Effective Date**"), by and between The Florida International University Board of Trustees, a public body corporate ("**FIU**" or "**University**"), on behalf of its various departments and colleges ("**Department**") and Litowitz Group, LTD, a Florida company, on behalf of Comfort Suites Miami, whose address is 11401 Bird Road, Suite 370, Miami, FL 3316, (the "**Hotel**").

WHEREAS, the FIU and the Hotel entered into that Master Hotel Agreement dated February 6, 2015 for accommodations, meeting space, and/or services for events (the "**Agreement**");

WHEREAS, the parties desire to amend the Agreement as set forth herein.

NOW THEREFORE, for and in consideration of the covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to modify the original agreement as follows:

1. **Amendment.** The Maximum Rate Schedule outlined in Section 17 – Rate Schedule in the Agreement, is hereby amended as follows for the period of January 1, 2016 thru December 31, 2016. Blackout dates shall apply for the period of January 1, 2016 through December 31, 2016. All other terms and conditions shall remain the same in effective.

3. **Conflict.** In the event of a conflict between the terms of this Amendment and the Agreement, the terms of this Amendment shall control.


4. **Capitalized Terms.** All capitalized terms used herein but not expressly defined herein shall have the meaning ascribed thereto in the Agreement.
