

**AMENDMENT TO THE AGREEMENT BETWEEN FIU AND HOTEL**

This AMENDMENT TO THE AGREEMENT (the "Amendment") is entered into on the last date signed below (the "Effective Date"), by and between THE FLORIDA INTERNATIONAL UNIVERSITY BOARD OF TRUSTEES, a public body corporate ("FIU" or "University"), for and on behalf its various departments and colleges ("Department") and TRUMP MIAMI RESORT MANAGEMENT, LLC, a Delaware company, on behalf of Trump National Doral, whose address is 4400 NW 87<sup>th</sup> Avenue, Miami, Florida 33178, who is authorized to do business in the State of Florida (the "Hotel").

WHEREAS, FIU and the Hotel entered into that Master Hotel Agreement dated March 5, 2015 for accommodations, meeting space, and/or services for events (the "Agreement");

WHEREAS, the parties desire to amend the Agreement as set forth herein.

NOW THEREFORE, for and in consideration of the covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to modify the original agreement as follows:

1. **Rate Schedule.** The following table shall be added to the end of Section 17 (RATE SCHEDULE) of the Agreement, for the period of January 1, 2016 through December 31, 2016:

2. **Ratification.** Except as modified hereby, all of the terms, covenants and conditions of the Agreement shall remain in full force and effect and are hereby ratified and affirmed.
3. **Conflict.** In the event of a conflict between the terms of this Amendment and the Agreement, the terms of this Amendment shall control.
4. **Capitalized Terms.** All capitalized terms used herein but not expressly defined herein shall have the meaning ascribed thereto in the Agreement.
